## The Emergency Food Assistance Program (TEFAP) Income Eligibility Guidelines

## EFFECTIVE OCTOBER 2025 UNTIL NOTIFICATION OF NEW INCOME GUIDELINES

NOTE: When receiving TEFAP USDA Food, the following is not required: social security number or identification, proof of citizenship, immigration status, household size, or income. However, an agency may request further client information for use with other programs.

Additionally, program information may be made available in languages other than English.
